## RESPONSIBILITIES

The Lil' Lentil King and Queen will reign for one year and tour the area, representing Pullman and lentils at various luncheons, on the Pullman community parade vehicle and the Lentil Express. The Lil' Lentil King & Queen visit approximately 10 parades with the Pullman Distinguished Young Women May through December of the year they reign and may be asked to make appearances at local schools leading up to the 2023 festival. Parents are expected to assist in coordinating Royalty events and activities. Activities are selected at the discretion of the National Lentil Festival.
